Total Skeet: 250 for Men and Women (75+50+75+50+Finals)

## **BASIC INFORMATION**

1. The United States Anti-Doping Agency (USADA) will conduct testing for banned substances.

## **ELIGIBILITY:**

All USA Shooting competitors must have a current USAS membership before the start of competition. Without a current membership you will not be able to participate in the competition.

Please ensure that your membership is current if you plan on attending. The match will be open to international guests as well. All international athletes should submit a copy of the picture page of their passport with their entry form.

## **INTERNATIONAL COMPETITORS**

International competitors are welcome to shoot this competition, provided they are members of their home federation. To register for this event, simply email your entry

form to [Jared.Esquivel@usashooting.org](mailto:Jared.Esquivel@usashooting.org) along with a copy of the picture page of your passport. Preregistration is required, and entry fees may be paid upon check-in at the event. International competitors must obtain a firearm permit to import a shotgun into the United States. USA Shooting will assist in obtaining the required import permit. Please download the BATFE 6NIA form from the USA Shooting website. ### **TEAM SELECTION JR**

**This match will serve as Junior World Championship Team Selection Process.** For more information please reference the Policies & Procedures posted online under the Resources tab.

There will be no Team Selection for Seniors, or Mixed Team Trap

### **SQUADDING TRAP & SKEET:**

Squads for PET days will be random for Skeet and Trap. Squads will be posted once registration is finalized. For the first course of fire, squads will be separated Men and Women and *will be based on total aggregate scores from 2019 Fall Selection*. For the second course of fire, squads will be separated Men and Women and will be squadded High to Low based on total aggregate score of Fall selection and Spring Selection first course of fire.

### **SQUADDING MIXED TEAM TRAP**

Squads for Mixed Team Trap events will be random.

### **RULES:**

Current 2019 ISSF Shooting Rules will govern this competition. It is the shooter's responsibility to be familiar with these rules. Match Directors Bulletins will also govern this match. See the Selection and Finals Procedures by clicking on this link below:

*Black or Grey shotshell wads will be allowed in competition.*

**JURY:**

A Competition Jury will be appointed. Decisions made by the Competition Jury are final.

**FEES:**

- EARLYBIRD ONLINE ENTRY, DOMESTIC: \$185 per event early entry
- NORMAL ENTRY AFTER February 16th, DOMESTIC: \$245 per event
- INTERNATIONAL SINGLE EVENT ENTRY: additional \$25 per event
- MIXED TEAM TRAP: \$90 per team (entry form in this packet)

Refunds will be granted until February 16th minus 15%. No refunds will be granted after February 23rd. Proof of Military deployment will receive a full refund.

**REGISTRATION:**

1. All competitors must be current members of USA Shooting.
2. The USA Shooting classification system will be used. It is the competitor's responsibility to confirm their age and classification upon check in. There will be no changes after the start of the competition.
3. Competitors must check in, verify their entry information and pick up their competitor number in person or be represented by their team official.
4. Check-in for all events will be done at the clubhouse, not later than noon the day prior to the first match day in which the athlete competes. If you cannot make it on time, please contact us at 719-866-4615 or by email at [Jared.Esquivel@usashooting.org](mailto:Jared.Esquivel@usashooting.org) .
5. Entries may be confirmed online or by calling 719-866-4615 or emailing Jared Esquivel the Competitions Division at [Jared.Esquivel@usashooting.org](mailto:Jared.Esquivel@usashooting.org).
6. Registration for those not previously entered will stop at noon on the official training day.
7. All competitors *should* have a PTO score on file with USA Shooting to compete in this match. Alternate evidence of international event operations knowledge and proficiency will be reviewed on a case-by-case basis. Should the number of entries received exceed range capacity; slots will be awarded based on an individual's highest PTO score (in the last 12 months) on record with USA Shooting.

This will take you through to the registration page, followed by the payment page. Please note we will accept entries up to range capacity.

**OPEN FINALS:**

1. Only U.S. citizens competing for the USA are eligible for Open finals. *Athletes, regardless of MQS (Minimum Qualifying Score) status, are eligible for finals. See <https://www.issf-sports.org/competitions/ogqualification.ashx> for more information on MQS Rules.*

2. If an Open finalist forfeits their slot in a Final, that slot will not be filled with another Athlete. The Open Men's and Open Women's champions, second place and third place finishers will receive medals. These awards are based on the total aggregate score from Fall selection + the total aggregate Score of Spring Selection.

### **JUNIOR / SENIOR / VISITOR FINALS:**

1. No Junior, Senior, or Visitor Final will take place at Spring Section/Olympic selection Part 2. Awards for Junior / Senior / Visitor will be based on Total Qualification Rounds Spring Selection Only.

### **MIXED TEAM FINAL**

1. Only U.S. citizens competing for the USA are eligible for finals.
2. If a finalist Team forfeits their slot in a Final, that slot will be filled with the next highest Team.
3. The Open Mixed Team Trap Champion, second place and third place finishers will receive medals. These awards are based on the current ISSF style format final.

### **AWARDS TRAP AND SKEET:**

2. 1st, 2nd, & 3rd place overall Open Men's and Women's finisher awards are based on high aggregate score of Fall Selection + high Aggregate score of Spring Selection. These finishers are not eligible for category awards.
3. Junior / Senior / Visitor awards are based on Total Qualification Rounds Spring Selection Only.
4. 3.Category awards will be given provided there are at least three entries in each category.

### **CATEGORY AWARDS TRAP AND SKEET**

Category Awards will be given out based on qualification scores only.

#### **a. Men's Categories**

- i. Collegiate Gold
- ii Junior, Gold, Silver, Bronze

#### **b. Women's Categories**

- i. Collegiate Gold
- ii Junior, Gold, Silver, Bronze

#### **c. Junior Categories**

- i. J2 Gold
- ii. J3 Gold

#### **d. Senior Categories**

- i. Senior Gold, Silver, Bronze

### **AWARDS MIXED TEAM**

1. 1st, 2nd, & 3rd place overall Mixed Team Trap awards are based on results of the elimination final.
2. No Junior, Senior, or Visitor awards will be awarded.
3. No Category awards will be awarded
4. We encourage all participants to stay for the awards ceremony and show support for fellow shooters. Those who are unable to attend the award ceremony should collect their award from the Entry Office, prior to leaving. Those who do not collect their award will be responsible for the mailing fees and contacting USAS for the award.

### **FIREARMS & AMMUNITION STORAGE:**

There will be no overnight firearms or ammunition storage at the range.

### **AMMUNITION:**

Federal Ammunition will be sold for \$85.00 per flat.

### **TRAINING ROUNDS:**

Open training can be purchased through the Tucson Trap and Skeet Club. Training will not be allowed after the first *competition* shot of the discipline has been fired. *No training in specific discipline after PET has started.*

### **EQUIPMENT CHECK:**

Equipment check will be performed on the fields. Skeet markers will be available for sale. Random ammunition checks will be made during competition. *Equipment check will be available on PET Day. It is the athlete's responsibility to ensure that they are in compliance with the rules.*

### **ACCOMMODATIONS:**

Please check the Match Information under the Events tab of the USAS website for any and all hotel discounts throughout the year.

### **SUBJECT TO CHANGE:**

Please keep in mind that the match schedule and squadding are subject to change. Although we make every attempt to maintain the published schedule, target malfunctions, weather and other items are out of our control. It is the responsibility of competitors and/or coaches to check the schedule and squadding daily and most importantly in the evening. Updated information will be posted to the web (under Events

– Match Information). It is also important to maintain a valid email address within our Sport:80 system, as we will send notifications via email (if needed). USAS is not responsible for missed flights, airline change fees, missed relays, etc. Please keep this in mind when making your travel arrangements and schedule.
