# NTC Shooting Club Junior Program

## Contract for Membership

NTC Shooting Club Junior Program members are expected to reach their own personal potential, and be successful in their chosen shooting sport. Each Club member and parent are to sign and return this contract to the Junior Program Lead upon becoming members.

**It is understood that any Junior athlete member of the NTC Shooting Club Junior Program will:**

1. Make safety the highest priority during Club training and competitions. Obey all Club rules for safety and range procedures during training at the Olympic Shooting Center.
2. FULLY COOPERATE with the Club Coaches, Range Officers, and Staff of the NTC Shooting Club, USA Shooting, and United States Olympic Training Center.
3. Understand that the Club and its members use the Olympic Shooting Center and range equipment with the permission of USA Shooting and the United States Olympic Committee, and abuse of the facilities and equipment will not be tolerated.
4. Attend a minimum of 75% of training sessions per month in the months September through May, unless absences are excused by the Group Coach.
5. Arrive at training on time and with a positive attitude.
6. Understand and abide by Club rules for level/group progression.
7. Train at or above a level of effort appropriate for current experience and level of training.
8. Develop and maintain a healthy coach-athlete relationship.
9. Understand that club equipment owned by the Club and while in the possession of the Club member is to be treated kindly and with attention deserving other people's property. Club equipment issued for the use of an athlete at home can be recalled, changed, altered by the Club at any time.
10. Abstain from the use of drugs, alcohol, and tobacco products.
11. Attend all competitions and events recommended by the member's Group Coach.
12. Conduct yourself with honor and selflessness at all competitions regardless of circumstances, and at all times show respect for other competitors and competition staff.

Sanctions: Failure to meet the above expectations may result in the Club Junior Program Lead (for major infractions) or Group Coach (for minor infractions) administering sanctions appropriate to the breach of any expectation of this agreement. Sanctions may include, for example, revocation of the privilege of Club membership, changes in access to Club equipment, ineligibility to compete in matches, placement in another Group, or loss of Travel Team reimbursements.

I have read and understand the expectations, and I will do my best to abide by the requirements of this contract. I understand that if I do not adhere to these guidelines I may receive sanctions as outlined above.
